Introductory Remarks

William Thompson, School Board Chair at Large, made brief opening remarks as follows:

- Welcomed the group, thanked everyone for coming out, thanked volunteer facilitators, thanked Good Group Decisions, thanked cafeteria staff for bringing food.
- Explained a little bit about the agenda initial presentations and then small groups. Asked for open minds and listening to each other's questions.

Facilitator Leigh Tillman made brief opening remarks as follows:

- Reviewed ground rules, objectives, and agenda for the meeting. See above.
- Thanks to Bill for opening. Leigh explained that she was here to help with process.
- Leigh explained that we are here to share and learn about the options and hear from each other.
- Leigh explained that we chose a "breakout model" for this meeting which means that we will be spending quite a lot of time in small group discussions.
- Leigh explained that there are two ways to give input today: in breakout groups and then in writing on a Community Input Form. Know that you have both of those opportunities.
- In response to someone's desire to speak to the entire group, Leigh encouraged the person to share those concerns right in the breakout groups. IF we move through everything smoothly there might be the opportunity at the end for anyone to speak to the whole group.
- Bill explained that the person was welcome to come to any school board meeting and that this meeting is intended to gather broad data from many members of community.

Presentations

The following presentations were made to provide background for the day's discussions.

History

Richard Ellis, Brunswick School Board, presented the following:

- In summer 2011 we began evaluating vendors to conduct an analysis of current facilities
- Harriman Associates was selected
- In Phase 1 of the Facilities Master Plan there were several engineering challenges identified
 - o In June 2012 a comprehensive report of building deficiencies was prepared
 - In June 2012 there was a vote to close Jordan Acres, expand Coffin, and renovate the Junior High School
- We engaged PDT Architects for those plans Phase 2 of Facilities Master Plan
- Many meetings were held and we looked at a variety of factors and options structural, size, location, expansion opportunities
- In 2013, options were presented for Coffin and JHS
 - We developed a concept which was a new 660-student Pre-K through Grade 2 school
- Eventually arrived at the point where we voted on specifically moving forward towards a repair plan, because we couldn't develop consensus on our Board
- Board voted 7-2 to do repair plan and address pressing issues
- Brought to Town Council and public referendum
- Council was not yet ready to support that plan but instead wanted to look at new building options
- It's been a weaving path
- We hope to take data from the past 5 years and your ideas today for solutions and what you see as the top deficiencies.
- We don't expect to have a final solution today but we are gathering good information from you.

School-Based Experience

Steve Ciembroniewicz, Coffin School Principal, and Walter Wallace, Brunswick Junior High School Principal, presented the following:

- We both have experience at schools and have been providing input to this process since 2011
- Junior High School experience
 - In depth and interesting process
 - Harriman met with whole staff to understand our needs: facilities and programming
 - o We also identified needs for breakout space for science, arts, etc.
 - We tried to involve all stakeholders.
 - PDT took all that work and clarified further.
 - They came up with drawings - 2 ideas for renovations
 - We considered those as staff and provided feedback
 - A Facilities subgroup looked at fifth grade projections - what would it be like to add a hundred more students, what are the programming needs, etc.



- Coffin experience
 - In 2012 we were looking at three draft plans for major renovations for Coffin
 - In January 2013, a more formalized plan was developed and there was some input from staff
 - There was a shift in focus when we considered new construction at Jordan Acres
 - o It was a very interactive process staff was very well heard
 - We looked at mock ups of plans
 - We imagined needs for a K-2 school
 - Lots of feedback was incorporated
 - o January 2014 was the last time we did work on this

Options for Moving Forward and Implications of Each Option

Lyndon Keck of PDT Architects described the four Master Plan options, making the following comments:

- Brunswick Schools have been working with 2 firms for 5 years on these issues
- Today is a great opportunity

- There are 3 major areas of struggle, as I see it
 - Old buildings
 - In America, in general, school buildings last 40 years and then we need to make major repairs, renovate, or build new
 - Coffin is now 61 years old
 - At the Junior High, the oldest part is 57 years old and newest wing is 33 years old
 - Buildings are tired and old
 - Cost to taxpayers
 - You have built 2 schools over last 18 years, so far with low impact on local taxes due to help from state
 - For Coffin and the Junior High, you do not have financial assistance from the State of Maine
 - Any solution, whether modestly affordable or very expensive, will fall entirely on local community
 - This is a struggle for the Board
 - You are also trying to do a Strategic Master Plan
 - You don't want to kick the can down the road
 - You are trying to anticipate problems in future, trying to be strategic
 - You don't want to have an orphan building with nothing done for 20 years
- The four options
 - General
 - There have been 2 dozen floor plans prepared, including replacements and renovations
 - Some of the most viable options included demolishing Jordan Acres and building a new school
 - At Coffin there are several schemes for light renovations and repairs, or for a new building
 - Several schemes for the Junior High as well
 - Board has narrowed options down to four
 - Too hard to effectively evaluate 15-16 options
 - o Option 1: Build new elementary school and repair Junior High
 - New elementary at Jordan Acres site
 - Common core facilities in the middle
 - o Option 2: Addition, renovation, and repair to Coffin and repair to Junior High
 - Large new addition to Coffin and modest renovations
 - Could be modest or expensive
 - Board trying to keep prices low
 - Option 3: Repair to both Coffin and Junior High and a 12-room portable unit at Coffin
 - Do repairs only to 2 schools
 - Board would continue to apply for financial help to build new school in the future
 - Would cost about \$12 million

- Repairs on the inside
- New portable structures at Coffin
- This is a "waiting" solution that addresses critical repairs
- o Option 4: Do nothing
 - No major repairs
 - Do small repairs as needed via CIP program
 - No major bond issue or referendum

Rich Ellis added the following comments on the presentation of the four options:

- Would like to clarify and emphasize that each of the first 3 options presume moving 2nd grade out of Harriet Beecher Stowe [HBS] and into other buildings.
 - o This would alleviate crowding issues at HBS
- The intent is to build a building to accommodate K-5 models
 - o Today we are focusing on the <u>building</u> itself not necessarily how the grades are physically configured. Consider building, neutral of configuration.
- Financial aspects of Option 1
 - O What it will cost the town and when?
 - The year over year tax impact is a 2.8-3.8% increase, then 3.87% in a few years
 - o Option 2B is cheapest though not as thoroughly evaluated
 - 4.46% is the year one tax impact
 - The range is 3.8 -4.46% in that year
 - Further out, taxes go down as bonds fall out
- Option 2
 - Operating costs will be more because there is more space
 - o 6.7% tax impact initially, then not as much later
- Option 3
 - o Costs of repairs to Coffin, Junior High, and new portables
 - o 1.5% tax impact
 - o There may be additional costs related to moving a bus garage

Process Going Forward

Bill Thompson presented on how today's Forum fits into the overall process:

- We plan to take data that we glean from today, reconvene as a Board, discuss, winnow down our options, and take to the Town Council.
 - Then it will be decided if it goes to public hearing or not.
- Hopefully there will be a referendum to vote as a community on one of the options
- We will present a specific option and the community can vote for or against it
- This is not your only opportunity to weigh in there will be other meetings of the School Board, Town Council, and public meetings to discuss that public referendum.
- This is not the only discussion we want to have about the future of our schools. We want to discuss what schools will look like to meet needs of our community
- Please stay engaged as a community
 - We want to hear your thoughts on how the buildings can be utilized as schools and how the buildings fit with the larger community
 - About 17% of the population use schools, yet we want to serve the community as a whole
- We want to produce the best kids in the state that we can all be proud of
- A final note some of you have expressed concern also about adding to our school programmatic budget. You get to vote on that in June. A reminder that we don't want to jeopardize our programs in favor of our facilities.

Key Issues - Breakout Session One

Everyone broke into small groups to discuss what people see as the key issues in determining how to proceed with a facilities plan.

Summary of Key Issues

Breakout groups prioritized key issues brainstormed and brought their top three key issues back to the whole group where the following themes were found.

- Operating Budget
- New School / New Site
- Creation of a Sense of Community
- Programming Considerations
 - What's best for kids
 - Quality of programs facilitated by building design
 - o Is K-5 right for Brunswick?
 - o Pre-K
- Long Term Flexible Solutions
 - Long term solution
 - Sustainable Solution (longevity)
 - Flexibility
 - o Flexible and changing models of education and a variety of age groups
 - Capacity for increased growth

Public Comments

After top key issues from all groups were reviewed and grouped by themes, the facilitator asked for any comments or reflections on the top key issues and themes generated. The following comments were made:

• It's almost all parents that are here today and this is not representative of the whole town (who pay the bills)



- Clarified that Option 4 is not only "do nothing" but also "start from scratch" or "I have another idea"
- There is an Option 5: Build a new elementary school on the High School grounds or at Brunswick Landing, repair Coffin and repair the Junior High School, and sell Jordan Acres.
 - Rich responded: We looked at the availability of land in town, at the High School, and at Brunswick Landing. We did consider it and there are issues with each site.

Public Comments on the Day's Discussions

After all groups reported out, the facilitator asked for comments and reflections from the whole group. The following comments were made.

- During the report-out for Option 4, it was very helpful that Drew gave us extra detail about the vote tallies:
 - There were 9 total votes on pros, 24 total votes on new ideas, and <u>99</u> total votes on cons!
 - o That is important
- Let's remember that there are options that have been supported by the School Board but shot down by the Town Council
 - Clarifying response: Option 3, repairs at JH and Coffin, was the only option brought before the Council
- How many people here are <u>not</u> parents, Town Council members, or paid employees of the schools?
 - o [1 person raised their hand]
 - o We give the schools \$37 million per year
 - We can't afford to give another 3% annual increase in taxes
 - o I am concerned about maintenance we have zero maintenance budgeted
 - o Option 4 should say "Maintain the schools we have already paid for"
 - o Consider our community. We are all in this together. I am concerned about additional financial stress on our community.
- Clarification that repairs to the Junior High are the same in Options 1 3. Also, the current mobile structures stay in all three options.
- It seems that there are some new ideas emerging. That is different than what I understood Option 4 was about.
- Option 4 could mean "We are going to continue to explore new ideas quickly" vs. "We are not taking any specific new actions"

William Thompson concluded the meeting with the following brief remarks:

For example, it eases the transition to sixth grade because the students are already familiar with one another.

- School board/ administration/ town council should be aware that we seem to be at a tipping point- there are increasing #'s of families who are finally fed up + are considering leaving the system (homeschool, private schools, etc.) Brunswick needs to support its schools in a bold, proud, community building way- we need our schools to again be an asset to our town- rather than a blemish.
- Schools serve us all whether or not we have kids in the system. An educated community benefits all. We need to educate our community on this. We being everyone here- not just school board's responsibility. Thanks for this opportunity to be educated + heard.
- Please, please, please reconsider a K-5 configuration. I think putting more grades together- keeping siblings/ families together in the same building for more years- is much more important than keeping school size smaller and will also make stronger school communities.
- Thanks to the facilitators for doing such a good job.
- Also concerned w/ reputation of Brunswick. For the health and growth of our townneed to be able to attract new citizens and keep those we have.
- The financing models are skewed and not the only option to fund the projects. Also do not incorporate maintenance costs and overall bigger picture budget considerations. Better presentation of \$ impacts over the lifetime at the schools is critical for a sound data based decision. K-5 needs to be part of the solution: process is facilities focused + budget focused and misses the keypad → educating students.
- PARENTS (who dominated public forum) have short-term concerns: is this teacher
 right for my child this year?; is my child in the right mix of age groups? TAXPAYERS
 (esp those without children in the schools who were not at the forum) probably, or
 may take a longer/ broader view: what will lead to a better community? How much
 can we afford? What is long-term impact cost of funding, longevity of town facilities?
- I did not expect to find myself getting excited about option 2- but I did... somehow the idea of: building on/ investing in something that is working, being "green" by refraining from demolishing an existing building, "saving" the JA site for potential

- use by a new Jr. High (which would continue to leave the K-5 population close together @ the HBS site and the Columbia street site) became appealing.
- It's important that we keep Brunswick as an attractive place for young families to move to and stay in.
