- d. Enrollment Report

It was expected that this year's enrollment would go down, however, as of yesterday the totals are about the same as they were at the end of the last school year: At Coffin, K-163; 1st grade-181; 2nd grade multi-age-34, for a total of 378. At HBS, 2nd grade-141; 3rd grade-191; 4th grade-186; 5th grade-184, for a total of 702. At BJHS, 6th grade-184; 7th grade-150; 8th grade-165, for a total of 499. At BHS, 9th grade-199; 10th grade-186; 11th grade-184; 12th grade-193, for a total of 762. Total student enrollment for the district is 2341 which is about the same as we ended last year. There was discussion about Charter Schools and their impact on our enrollment.

- e. Strategic Planning Update – Pender Makin

The Strategic Planning work group met last week and are planning to meet as a group on September 18th with the consultants, Good Group Decisions, to discuss the process and structure that they will be going through. The group will be reaching out to the community to get feedback and input into the development of a strategic plan.

- f. Title I Update – Pender Makin

Title I is a federal grant to help meet the needs of students particularly those identified as needing supplemental instruction in math and literacy. Coffin is our Title I school and we have used some of the carryover funds to help bolster the literacy and math programming at Coffin: Coffin had a .5 math interventionist that we were able to increase to .8; We also developed a Saturday program, Cub Camp, giving those identified students an additional day for math and literacy immersion. There can be five 6-week sessions.

- g. **Teacher Induction Program – Pender Makin**
In an effort to recruit, develop, support, and retain world-class educators for the Brunswick district, we have completely revamped the teacher induction program so it more resembles a course. Teachers will be working on Maine’s standards for beginning teachers and will be able to earn certification contact hours at the same time. It will run for 2 years. Its purpose is to nurture new teachers and provide support, keeping them excited about teaching and not overwhelmed.
- h. **Update on revolving renovation application– Paul Caron**
September 30 is the deadline and we are close to completing the application. Mr. Caron went over the list of renovations to Coffin and HBS that will be in this application. It will be brought to the Board at a special meeting on September 23rd. Mr. Caron explained the process.
- i. **Update of the State Board of Education visit at HBS**
The State Board of Education had a workshop this morning at HBS and then the Superintendent was able to talk to them regarding some of the issues we are facing.

Board Chair’s Report

- a. **Meetings**
There is a change of date for the Board’s joint meeting with the Town Council. It will be held on September 23rd at 6:30pm at Coffin School to possibly include a tour of the school. Mr. Thompson, the Town Council Chair, and Ms. Prescott are also hoping to set up an informal meeting within the next few days.
- b. **Student Liaison Report**
Ms. Gramins reported that the senior class kick-started their graduation fundraising by helping to keep the grounds clean at the recent air show. With the help of Mr. Wilson and Mrs. Wagner the upperclassmen have put together a new mentoring program for freshmen. Three students at the high school have created an independent project, doing a clothing drive for underprivileged children at the Jr. High. They are requesting donations of gently used clothes.
