2021 Budget Presentation:

BJHS / BHS / Athletics Special Education REAL School Personnel Student/Staff Support

Ms. Wentworth gave a presentation on the 2021 budget for BJHS, BHS Athletics & Co-Curricular, Special Education, REAL School, and administrative requests. She reviewed increased costs, proposed tier 1, 2, and 3 administrative requests, drivers of the proposed budget, a summary of year-over-year change, as well as the proposed budget tax impact. She answered questions from Board members throughout her presentation.

There is another budget presentation scheduled for March 11. There will be a Public Forum held on March 18, and another budget workshop scheduled, if needed, for March 25 before presenting our budget to the Town Council in April.

For the next meeting, the Board requested the expected operating costs for Coffin School next year; the Transportation Director be available for questions; and which year would the remaining funds from the building contingency fund offset the debt service.
