Communications/Correspondence

Mr. Corey said he had received correspondence from Water Street residents with concerns about a bus garage being located in their neighborhood.

Public Participation

Mr. Moll, Mr. McGrath, and Mr. Kilpatrick spoke as members of the Water Street Neighborhood Association about concerns with placing a bus garage at the site of the old Times Record building on Industry Road. Ms. Callajan and Ms. Singer, representing Brunswick Community United, offered to assist with Phase II of the Facilities Master Plan that deals with renovations of Coffin and the junior high schools. Ms. Prescott made several suggestions, including a dedicated website to communicate facilities work to the community.

Mr. Grant entered the meeting at 7:25 p.m.

Superintendent's Report

a. Report from Student Government - Satchel Toole

Satchel Toole, grade 11, reported on activities of the high school student government that included cell phone rules changes, plans for the annual winter carnival, and organizing a school dance.

b. Annual Yearly Progress Report - Mr. Bartlett

Mr. Bartlett reported on annual yearly progress for the 2011-2012 school year. He said that although Coffin and Stowe Schools appeared to make A.Y.P., they probably will not when the next NECAP scores come out due to the high proficiency rates. He mentioned that the junior high school's scores were good but they failed to make A.Y.P. due poor daily attendance by one subgroup. The high school's whole school SAT scores are good; however, A.Y.P. continues to not be met due to the high proficiency rates required and low scores by some subgroups. He stated that the high school's graduation rate went up to 89.4% and the dropout rate dropped to 2.02%.

Ms. Clough stated that the committee heard a report about an increase in special education students, and had overviews of the Gifted and Talented and Alternative Education programs.

Ms. Joyce said the committee discussed Math in Focus at the junior high level, and checked on compliance with the civics course requirement.

c. Policy Committee 12/3/12 - Ms. Small

As a result of parent requests for classroom observations and a school memo sent to parents on this topic, Ms. Small said the committee developed classroom observation policies.

d. Personnel and Negotiations Committee 11/19/12 – Mrs. Perreault

Mrs. Perreault said the committee met to look at proposals for negotiating with the bus drivers, custodians and educational technicians.

Mr. Ellis reported that the committee discussed the State subsidy, town evaluations, and the budget surplus. They considered the Superintendent's 3-year goal of hiring a new grade 2 teacher, increasing Gifted and Talented resources and staff, procuring a new data entry program, and hiring a grade level teacher to follow classes. The committee looked at a proposed budget workshop schedule, and encouraged public feedback.
