DISTANCE LEARNING

GRADES PREK - 5

GRADE 9

Students will be assigned to one of four cohorts. Cohort A will attend in person Monday. Cohort B will attend in person Tuesday. Cohort C will attend in person Thursday. Cohort D will attend in person Friday. The other four days of each cohort's week will be at home-learning.
